#### **DEPARTMENT HEAD REPORTS:**

Doug Myer – solar project is 85% complete; Highway Department is taking care of weather situations.

Greg Chorvas – ice arena is open to private groups and this Saturday will be open to the public. We have had a tremendous out-pouring of volunteers to get the ice rink ready. There have been three problems with the chiller but unrelated to the renovation. Rich Praetorius has donated all his services to the Town of Saugerties for 2017 and 2018.

Chief Sinagra – the situation that was brought up last month regarding Formisano's unregistered vehicles has been checked into; there were 3 unregistered and they have been taken care of. The monthly report for the Police Department is on file at the Town Clerk's Office.

Claudia Andreassen – Narcan meeting was very interesting and all arrests have been taken care of. There are many changes in the laws coming in January.

# **BOARD COMMITTEE REPORTS:**

Councilman Andreassen – welcome to all; with regard to memorializing resolution, feel free to come to him if you ever feel threatened. HPC will be working on archiving. Malden Sewer will have some up-grades; thank you to highway for storm work. Planner Dan Shuster is retiring and ZBA member Samantha Dederick is stepping down. It was a pleasure to work with Mike MacIsaac and thank you to Joe Maloney for his time and work in the legislature.

Councilwoman Thornton – poinsettias are ready for pick up from the Boys & Girls Club fundraiser. TV23 meets in January; CPC meets end of January, STAC is working on thruway/Route 32 intersection.

Councilman Schoonmaker – received a decision on Karolys case in favor of the Town of Saugerties and can now be enforced. The Animal Shelter held its annual sale, which was well attended and the capital campaign has begun for the shelter – it will be a unique design! Shout Out Saugerties holding pop up books at the gallery.

### **MOTIONS & RESOLUTIONS:**

Motion made by Councilman Schoonmaker, seconded by Councilwoman Thornton to move Patrick Maloney from temporary full time status to permanent full time status, effective

December 12, 2019, with no increase in current pay rate, to fill position previously vacated on August 14, 2019, as per the recommendation of the Parks & Buildings Superintendent.

Motion made by Councilman Andreassen, seconded by Councilwoman Thornton to add to the Parks & Buildings Security call out list, Joseph R. Quirk, at a rate of \$15.00/hour as per the recommendation of the Parks & Buildings Superintendent.

Vote: Adopted – 4 Yes (Councilman MacIsaac absent)

Motion made by Councilwoman Thornton, seconded by Councilman Andreassen to add to the Parks & Buildings Custodial and Security call out list, Joseph B. Wells, Jr., at a rate of \$15.00/hour as per the recommendation of the Parks & Buildings Superintendent.

Vote: Adopted – 4 Yes (Councilman MacIsaac absent)

Motion made by Supervisor Costello, seconded by Councilman Andreassen to authorize the transfer of \$17,068.43 from the Saugerties Festival Development Corporation, Account #15004229652620 to Account #B7110.432 Real Estate Taxes for taxes paid to Northeast Solite in 2018 and 2019 prior to closing on sale of property, as per the recommendation of the Town Account and Town Supervisor.

Vote: Adopted – 4 Yes (Councilman MacIsaac absent)

Motion made by Councilman Schoonmaker, seconded by Councilwoman Thornton to authorize the transfer of \$15,000.00 from Saugerties Festival Development Corporation Account #15004229652620 to Account #B7110.200 Equipment and Capital Outlay, for the procurement of the Terpening Memorial Park Pavilion, along with related materials, as per the recommendation of the Town Accountant and Town Supervisor.

Discussion: The Terpening Family pledged money for this and this represents the balance.

Vote: Adopted – 4 Yes (Councilman MacIsaac absent)

Motion made by Councilman Andreassen, seconded by Councilwoman Thornton to approve the list of Facility Use Fees, Rental and Services Charges and Surcharges, for resident and non-residents, as per list on file, as per the recommendation of the Parks & Buildings Superintendent.

Vote: Adopted – 4 Yes (Councilman MacIsaac absent)

Motion made by Councilwoman Thornton, seconded by Councilman Schoonmaker to accept the stipulation of agreement and the resignation of Dennis Pearce, effective December 6, 2019. Vote: Adopted – 4 Yes (Councilman MacIsaac absent)

Motion made by Supervisor Costello, seconded by Councilwoman Thornton to approve the Street Lighting Authority Order, as on file, between the Town of Saugerties and Central Hudson Gas & Electric Corporation.

Discussion: Supervisor Costello clarified that this is a street light in Mt. Marion district.

Vote: Adopted – 4 Yes (Councilman MacIsaac absent)

Motion made by Councilman Schoonmaker, seconded by Supervisor Costello to approve the resolution, as on file, condemning violence, hate speech and symbols of hate put forth by citizens of Saugerties.

Discussion: Councilman Schoonmaker added that we can not infringe on rights, this is a memorializing resolution; while we cannot stop it, we don't like it.

Vote: Adopted – 4 Yes (Councilman MacIsaac absent)

Motion made by Councilman Andreassen, seconded by Supervisor Costello to award the bid of December 5, 2019 for \$54,668.50 to Sawyer Motors for the purchase of one 2019 Ram 3500 chassis cab 60" 4x4 truck equipped with a 6.4L hemi gas engine and 6 speed HD Alisin automatic transmission for the Water & Sewer Department.

Vote: Adopted – 4 Yes (Councilman MacIsaac absent)

Motion made by Councilwoman Thornton, seconded by Councilman Andreassen to hire John Hanzl full time in the Water & Sewer Department at a rate of \$17.00 per hour.

Vote: Adopted – 4 Yes (Councilman MacIsaac absent)

Motion made by Supervisor Costello, seconded by Councilwoman Thornton that Resolved, the Town of Saugerties approves submitting an application for \$500,000.00 to the Department of Agriculture and Markets 2019-2020 NYS Companion Animal Capital Projects Fund for the purpose of building a new Animal Welfare Shelter at a total projected cost of \$1.5 million. The town's 25% match is expected to arise from in-kind construction services and if necessary, the Saugerties Animal Welfare Fund, which currently has raised \$400,000.00 toward the Project. Vote: Adopted – 4 Yes (Councilman MacIsaac absent)

Motion made by Councilman Schoonmaker, seconded by Supervisor Costello to enter into Executive Session regarding matters relating to public employee collective-bargaining negotiations at 8:37 p.m., carried.

Motion made by Councilman Schoonmaker, seconded by Supervisor Costello to exit Executive Session and adjourn Town Board Meeting at 9:20 p.m., carried.
