### **PUBLIC COMMENT PERIOD:**

Gil Hales – would like to congratulate the board for bike routes in Saugerties, which was a project for the village and town. A new brochure is available and Economic Development and Chamber of Commerce is distributing the brochures. Thank you to Bernie Ellsworth, Mike Campbell and public employees, hopefully encourage more people to ride.

Mike Valleralla – gave information to town board members representing residents at Tissal Road, dangerous and hazardous conditions.
