Councilwoman Thornton – SAMA meeting regarding Route 9W will take place next Thursday at the Senior Center. CPC workshop will be held at the FDR property regarding signs, conservation easements, maps, planning and zoning. Library board met last night and July 25th is an informational meeting where the architect will be presenting options for a new library and the board will make their decision on September 15, 2006. Public Access TV 23 apologizes for the "snowy" conditions due to technical difficulties. Thank you to Markertec and Tom Moratti for help along with Mike Campbell and Ken Stanley. CAC meeting is next Thursday at a location to be announced and are working on "smart growth".

Councilman Costello – compliment Supervisor, Sgt. Tucker, police and fire departments for preparedness during flood. Glasco Mini Park and warehouse office space moving along. Will hire two full time police officers tonight to fill vacancies.

Councilwoman Campbell – Economic Development Committee has heard from a couple of firms giving presentations and hopes to work with one of the firms to draw up strategies. Planning and Zoning have completed their education courses and will be certified for two years. Filed grant for implementing sidewalks and bicycle paths from Village to Cantine Complex.

In the matter of the formation of the Glasco Ponds Stormwater Management District situate in the Town of Saugerties, Ulster County, New York (S/B/L # 28.4-4-7), pursuant to Sections 191 through 194 of the New York State Town Law.

WHEREAS, a written Petition, dated October 4, 2005 in due form and containing the required signature of the Glasco turnpike Operating, LLC attorney on behalf of said Petitioner, as sole fee owner of the Glasco Ponds sixty eight (68) lot residential subdivision, has been presented to and filed with the Town Board of the Town of Saugerties, Ulster County, New York for formation of the Glasco Ponds Stormwater Management District, together with the following documentation annexed thereto:

- 1. Drainage District Report prepared by Praetorius and Conrad, PC.
- 2. Stormwater Drainage District Agreement.
- 3. Deed to the subject premises.
- 4. Metes and bounds descriptions of the stormwater management facilities; and,
- 5. Proposed Stormwater District Maps, dated September 15, 2005 and as prepared by Praetorius and Conrad, PC; and,

WHEREAS, the foregoing documentation has been reviewed as to form and sufficiency by the Town Board, the Town Attorney and the Town Engineer in order to proceed to this Resolution; and,

WHEREAS, the lands aforesaid, which consist of a 47.47 acre area which shall comprise the Glasco Ponds Stormwater Management District facilities.

RESOLUTION DATED JULY 12, 2006 TO PROHIBIT TRUCK TRAFFIC AND POST "NO THRU TRAFFIC" SIGNS ON PLATTE CLOVE ROAD IN THE TOWN OF SAUGERTIES

WHEREAS, the Highway Superintendent of the Town of Saugerties has determined the safety, configuration and characteristics of Platte Clove Road in the Town of Saugerties does not meet the criteria for continuous thru truck and tractor-trailer traffic and should be used for local deliveries only; and

WHEREAS, a legal review of Section 1660(a) 10 and 17 of the Vehicle and Traffic Law offers the Town Board the ability to regulate and limit tractor-trailer and tractor-trailer combinations in excess of a combined weight of ten thousand pounds; and

WHEREAS, a "Trailer" means every vehicle with or without motive power, designed for carrying persons or property and for being drawn by a motor vehicle and so constructed that no part of its weight rests upon the towing vehicle; and

WHEREAS, a "Truck" means every motor vehicle which is designed, used or maintained primarily for the transportation of property; and

WHEREAS, the truck route limitations prescribed in this Resolution shall not apply to:

- (a) Fire trucks or other emergency vehicles or vehicles on emergency business involved in the saving of life or property; or
- (b) Implements of husbandry incidentally moved upon a road; or
- (c) Road repair, construction or maintenance vehicles while involved in the repair, construction or maintenance of road within the town;
- (d) Local delivery vehicles; and so

NOW, THEREFORE, BE IT RESOLVED that the Town of Saugerties Highway Superintendent shall procure and have posted appropriate signs along the designated routes as required by the laws of the State; and

BE IT FURTHER RESOLVED that "No Thru Traffic Road – Local Deliveries Only" signs be posted on Platte Clove Road in the Town of Saugerties with a maximum weight limit of 5 tons or more noted on the aforementioned road; and

BE IT FURTHER RESOLVED that copies of this Resolution will be forwarded to the Town of Saugerties Police Chief, Ulster County Sheriff's Department and New York State Police as notification and proof of the new road designation and limitations; and

BE IT FURTHER RESOLVED that this Resolution is to take effect immediately upon installation of signage under the direction of the Highway Superintendent.
