Property Tax Reform rally on May 8th throughout NY at noon in Albany. CPC will meet next Thursday at 7:00 pm regarding open space and conservation subdivision. SAMA meeting scheduled for next Tuesday. Also, on April 27th at 1:00 p.m. there will be a meeting regarding a reverse mortgage seminar for seniors sponsored by M & T Bank.

Councilman Costello – compliment John Scheffel coordinating an emergency disaster drill (bus roll over) with a number of agencies participating on May 7th. Glasco Mini Park work will begin next week. Blacktop paving being completed at Town Hall.

Councilwoman Campbell – SPAZ paintball was given approval from Planning Board, will be opening soon. Letters going out to all applicants stating all fees will be paid in advance for workshops, etc. Letter sent to Department of Interior from town, village and No Casino Group asking they take charge instead of Bureau of Indian Affairs.

MOTIONS & RESOLUTIONS:

Motion made by Councilman Costello and seconded by Supervisor Helsmoortel, to approve \$10,000.00 (ten thousand dollars) for the Esopus Creek Conservancy out of the Recreation Trust Fund as per previous agreement during the 2006 Budge finalization. Vote: Adopted – 4 Yes (Councilwoman Thornton abstained as she is on the board of the conservancy)

Motion made by Councilwoman Costello, seconded by Councilman Leighton to approve \$1,000.00 (one thousand dollars) expenditure for a monument at Cantine Field honoring those who lost their lives on September 11th.

Discussion: Councilman Costello acknowledged Sonny Solitto for his efforts in organizing the September 11 services. Vote: Adopted – 5 Yes

Motion made by Councilwoman Campbell, seconded by Councilman Costello to grant a stipend to Alvie Weeks and to Henry Ziegler during the time Paul Andreassen is on leave of absence. The stipend for three months for Alvah Weeks will be \$1,500.00 and the stipend for three months for Henry Ziegler will be \$800.00, total. Vote: Adopted – 5 Yes

Motion made by Councilwoman Campbell, seconded by Councilman Costello that the above motion be retroactive to April 3, 2006. Vote: Adopted – 5 Yes

Motion made by Councilman Costello, seconded by Councilwoman Campbell to approve the amount not to exceed \$150.00 for the purpose of supplying refreshments for the interemergency drill on May 7, 2006. Vote: Adopted – 5 Yes

Motion made by Councilman Costello, seconded by Supervisor Helsmoortel to approve change order #1 in reference to the Contract #GSA052 Town Hall Drainage and Blacktop Project in an amount not to exceed \$7,650.00 as per the recommendation of the Parks and Recreation Superintendent and Town Engineer.

Discussion: This is to extend the area for the DMV van not to block the new windows in the warehouse, improve drainage and more accessible parking for court. Vote: Adopted – 5 Yes
