Councilman Schirmer – nothing to report

Councilwoman Thornton – on March 5th Solarize Saugerties will hold an informational meeting from 3:00 to 5:00 p.m.at the Senior Center with follow-up sessions. CAC held a meeting regarding non-evasive aggressive plants; Round-Up is a good solution. Master Gardner Barbara Bravo spoke. At the CPC meeting solar panels was discussed and wording with the Comprehensive Plan.

Councilman Costello – regarding the outdoor boilers, if we passed a law, it may not ban activity; we do our best. The impound lot work has been slowed due to the weather.

Councilman Bruno – will have the Building Department report at the next meeting.

MOTIONS & RESOLUTIONS:

Motion made by Councilman Schirmer, seconded by Councilman Bruno to approve the resolution, as on file, extending the 2011 sales tax sharing agreement between the County of Ulster and the City of Kingston for an additional five year term.

Discussion: Councilman Schirmer said that the sales tax sharing agreement expired on February 29th. Supervisor Helsmoortel said especially since the 2016 budget is done.

Vote: Adopted – 5 Yes

Motion made by Councilman Bruno, seconded by Councilman Costello authorizing Transfer Station Department Head Douglas F. Myer the authority to solicit bids and award said bid to the lowest qualified bidder meeting all provided specifications for one new Vertical Cardboard Baler providing lowest qualified bid does not exceed \$11,500.00.

Discussion: Doug Myer said that we have not been utilizing services of RRA since January 1, 2016; this should be paid for in two years.

Vote: Adopted – 5 Yes

Motion made by Supervisor Helsmoortel, seconded by Councilman Bruno to approve hiring Margaret (Terri) Bartosik as a part-time clerk on an as needed basis in the Tax Collector/Bookkeeping Department at a pay rate of \$12.50 per hour, effective immediately. Vote: Adopted – 5 Yes

Motion made by Councilman Bruno, seconded by Councilwoman Thornton to set two public hearings, one on April 20, 2016 at 6:30 p.m. and one on May 18, 2016 at 6:30 p.m. regarding amending a zoning law to include the clause "Bottled and bulk water storage for non-potable water only."

Discussion: Councilman Bruno added that this is in place to protect the aquifer.

Vote: Adopted – 5 Yes

Motion made by Supervisor Helsmoortel, seconded by Councilman Costello to adjourn Town Board Meeting at 7:30 p.m., carried.
