BOARD COMMITTEE REPORTS:

Councilman Andreassen – thank you to all departments for 9-11 service. Food truck festival was well attended. HPC met to restore the park in Malden with the USS Maine. Also, attended the Planning Board meeting last night.

Councilwoman Thornton – met with videographer showcasing Saugerties, there will be four chapters nationwide. Senior Education Committee will have their first meeting on Monday. TV23 members will be presenting an information session at the fall Chamber meeting. Boys & Girls Club had a camp wilderness program done this summer. There will be a ribbon cutting ceremony at Esopus Bend for the new pavilion on September 26 with a hike at 5:30 and meeting at 6:30 p.m.

Councilman MacIsaac – a lot of shovel ready sites but zoning is too restrictive on Kings Highway, would like to move forward with changes. CAC meeting is tomorrow and Climate Smart has a new website.

MOTIONS & RESOLUTIONS:

Motion made by Councilwoman Thornton, seconded by Councilman Andreassen authorizing Highway Superintendent Douglas Myer the authority to enter into the Shared Service agreement, as on file, between the Town of Saugerties and the Town of Woodstock for the coownership of a Road Widening Machine with a cost not to exceed \$10,000.00. Discussion: Doug Myer said this is a different type of agreement to co-own. The usual rental is \$3,500.00 per week.

Vote: Adopted – 4 Yes (Councilman Schoonmaker absent)

Motion made by Councilwoman Thornton, seconded by Supervisor Costello to approve the resolution, as on file, for the Intermunicipal Agreement between the Town of Woodstock and the Town of Saugerties for the co-ownership of one (1) Road Widening Machine. Vote: Adopted – 4 Yes (Councilman Schoonmaker absent) Motion made by Councilman Andreassen, seconded by Supervisor Costello to approve the resolution, as on file, pertaining to an application for a grant through Greenway for the Katherine Terpening Memorial Gazebo at the George Terpening Memorial Park. Discussion: Supervisor Costello added that the family has up-graded the park and with the recent passing of Katherine, would like to apply for the grant for additional improvements. Vote: Adopted – 4 Yes (Councilman Schoonmaker absent)

Motion made by Supervisor Costello, seconded by Councilman Andreassen to hire Brent P. VanNosdall as part time police officer at a pay rate of \$21.00 per hour, effective September 20, 2018.

Vote: Adopted – 4 Yes (Councilman Schoonmaker absent)

Motion made by Supervisor Costello, seconded by Councilman MacIsaac to hire James Secreto as a part time police officer at a pay rate of \$21.00 per hour effective September 20, 2018. Discussion: Chief Sinagra said that he just retired February 2018 from the NYC PD. Vote: Adopted – 4 Yes (Councilman Schoonmaker absent)

Motion made by Supevisor Costello, seconded by Councilman Andreassen to hire Tyffani Haines as a part time dispatcher at a pay rate of \$17.53 per hour, effective September 20, 2018. Vote: Adopted – 4 Yes (Councilman Schoonmaker absent)

Motion made by Councilman MacIsaac, seconded by Councilwoman Thornton to add to the part time Ice Arena call-out list Samantha Lee Okuniewicz, at a rate of \$11.50 per hour, per the recommendation of the Ice Arena Director and the Parks & Buildings Superintendent. Vote: Adopted – 4 Yes (Councilman Schoonmaker absent)

Motion made by Councilman MacIsaac, seconded by Supervisor Costello to set a public hearing date of October 17, 2018 at 5:00 p.m. regarding the adoption of a Local Law to amend Chapter 232-6 of the Municipal Code of the Town of Saugerties entitled "Stop and Yield Intersections". Vote: Adopted – 4 Yes (Councilman Schoonmaker absent)

Motion made by Councilman Andreassen, seconded by Supervisor Costello to set a public hearing date of October 17, 2018 at 5:30 p.m. regarding the Malden Sewer District pertaining to changing the manner of billing for operation and maintenance from units to usage and providing for quarterly billing.

Discussion: Councilman Andreassen added that we are increasing the water rates and Malden needs to be changed to usage like Glasco and Barclay Heights.

Vote: Adopted – 4 Yes (Councilman Schoonmaker absent)

Motion made by Councilman Andreassen, seconded by Supervisor Costello to set a public hearing date of October 17, 2018 at 6:00 p.m. regarding all town sewer and water districts pertaining to changing the frequency of billing for operation and maintenance from semi-annual to quarterly billing.

Discussion: Supervisor Costello said it will be better budgeting than only twice a year billing. Now that the district can be read more quickly, it is much easier. Councilman Andreassen said quarterly billing will be less of impact when rates are raised. Vote: Adopted – 4 Yes (Councilman Schoonmaker absent)

Motion made by Supervisor Costello, seconded by Councilman MacIsaac to adjourn Town Board Meeting at 8:05 p.m., carried.
