Motion made by Councilman Costello, seconded by Councilman Leighton to authorize Patrick Landewe, Village Trustee, to complete the OPRHP Environmental Protection Fund (EPF) Grant, "Park Development and Planning Program" for the resubmittal of the joint Village and Town Trails Grant, originally submitted last year as per the recommendation of the Parks and Buildings Superintendent.

Motion made by Councilman Costello, seconded by Supervisor Helsmoortel to accept the following resolution, That Greg Helsmoortel, as Supervisor of the Town of Saugerties and William Murphy, as Mayor of the Village of Saugerties are hereby authorized and directed to file an application for funds from the New York State Office of Parks, Recreation and Historic Preservation in accordance with the provisions of Title 9 of the Environmental Protection Act of 1993, in an amount not to exceed \$370,000.00, and upon approval of said request to enter into and execute a project agreement with the State

for such financial assistance to the Town and Village of Saugerties for a recreational trail system and, if appropriate, a conservation easement/preservation covenant to the deed of the assisted property.
