WATER DISTRICT IN THE TOWN OF SAUGERTIES

WHEREAS, a map, plan and report providing for extension of the Kings Highway Water District along Kings Highway in the Town of Saugerties were prepared and filed in the office of the Clerk of the Town of Saugerties; and

WHEREAS, a copy of the order was published in the Hudson Valley One not less than ten (10) days nor more than twenty (20) days before the day set in the order for the hearing and a copy of the order was also posted on the bulletin board of the office of the Town Clerk, and on the Town's website; and

WHEREAS, a public hearing on the proposed Kings Highway Water District Extension was held on April 17, 2024, at the Frank D. Greco Senior Citizens Center, on Robinson Street, in the Village of Saugerties, at which time all persons interested in the subject matter were heard; and

WHEREAS, the proposed extension of the Kings Highway Water District is a Type II action requiring no SEQR determination of significance, EIS or findings statement under the State Environmental Quality Review Act ("SEQR"), and its implementing regulations, 6 NYCRR Part 617, as the action involves an extension of existing water district and water main to allow for new building connections by individual property owners; and

WHEREAS, the Town Board has determined it is in the public interest to approve the proposed Kings Highway Water District Extension along Kings Highway, in the Town of Saugerties;

NOW, THEREFORE, BE IT

RESOLVED, that the proposed extension of the Kings Highway

Water District along Kings Highway in the Town of Saugerties be, and the same hereby is approved as being in the public interest, subject to a permissive referendum, as required by Section 209-q of the Town Law; and it is further,

RESOLVED, the estimated annual capital cost to the typical property owner with an assessment of \$290,000.00 is \$1.33 for every \$1,000.00 of assessed value, equals \$385.70 at a cost of \$179.41, and the estimated yearly cost for water usage for the typical property owner is \$541.00, resulting in a total estimated cost/connection per year of \$927.00; and it is further,

RESOLVED, that the costs of the Kings Highway Water District are to be annually apportioned and assessed upon the several lots and parcels of land especially benefitted by the improvement in proportion to their assessed value for tax purposes; and it is further,

RESOLVED, that the boundaries of the benefitted area of the Extension are as shown on a map of the Proposed Extension to Kings Highway Water District, a copy of which is annexed to this resolution and made a part hereof as Exhibit A, and a description of the parcels included in the extension is annexed to this resolution and made a part hereof as Exhibit B; and it is further,

RESOLVED, that all the property and property owners within the proposed extension are benefitted thereby and all the property and property owners benefitted are included within the limits of the district extension; and it is further,

RESOLVED, that the Town Clerk within ten (10) days of the adoption of this resolution cause two (2) certified copies of the resolution to be filed in the Office of the State Comptroller at Albany New York; and one (1) certified copy in the Office of the Ulster County Clerk; and it is further,

AGREEMENT

This Agreement is made, and shall be effective, as of the last date of the signatures below, ("Agreement") between Town of Saugerties, with a principal address of 4 High Street, Saugerties, New York 12477, ("Licensor") and Cellco Partnership, d/b/a Verizon Wireless, with a principal address of One Verizon Way, Mail Stop 4AW100, Basking Ridge, New Jersey 07920 (telephone number 866-862-4404) ("Licensee").

- 1. Licensor hereby grants unto Licensee a license to use a 50' by 50' parcel located at Near 341 Washington Ave Ext., Saugerties, New York 12477; Tax ID: 18.1-3-38 ("Property"), which is more particularly described on Exhibit A attached hereto and made a part hereof, together with the right to place upon the Property a communications facility ("Facility"). Licensor also grants unto Licensee the non-exclusive right-of-way for ingress and egress, 7 days a week, 24 hours a day, on foot or motor vehicle, including trucks. Said right-of-way and Property are generally described on Exhibit A attached hereto and made a part hereof. Further, Licensee shall have the right to install and maintain conduits, pipes, cables and wires to its Facility within the Property as necessary to supply utility service and power to the Facility or as otherwise needed to service the Facility as reasonably determined by Licensee.
- 2. The term of this Agreement shall be for the period from 09/14/2024 through and including 10/06/2024.
- 3. In consideration for the rights granted herein, Licensor's Property will receive the benefits of enhanced wireless communications arising from operation of the Facility.
- 4. Licensee reserves the right to terminate this Agreement on 30 days written notice and upon such termination, Licensee will remove all of its equipment and improvements and restore the Property to its original condition, normal wear and tear excepted.

5. Licensor and Licensee shall indemnify, defend and hold the other harmless

against any claim of liability or loss from personal injury or equipment, property damage

resulting from or arising out of the negligence or willful misconduct of the indemnifying

party, its employees, contractors or agents, except to the extent such claims or damages may

be due to or caused by the negligence or willful misconduct of the other party, or its

employees, contractors or agents. Licensee shall maintain at its own expense during the term of

this Agreement, commercial general liability insurance with a combined single limit of

\$1,000,000.00 for bodily injury and property damage. Licensee shall provide a certificate of

insurance to Licensor as proof of said coverage which shall contain a provision for 30 days'

notice of cancellation to Licensor. The Town of Saugerties shall be listed as additionally insured

Except with respect to the indemnification set forth in this paragraph, neither party shall be liable

to the other, or any of their respective agents, representatives, employees for any lost revenue,

lost profits, loss of technology, rights or services, incidental, punitive, indirect, special or

consequential damages, loss of data, or interruption or loss of use of service, even if advised

of the possibility of such damages, whether under theory of contract, tort (including

negligence), strict liability or otherwise.

6. Licensor covenants that Licensee, upon performing the covenants set forth herein,

shall peacefully and quietly have, hold and enjoy the Property. Further, Licensor covenants that




