Discussion: Supervisor Helsmoortel added that Frank Orlando did a presentation a couple months ago explaining the reval.

Motion made by Councilman Costello, seconded by Councilwoman Campbell to approve the payment of the property taxes on leased Parcel 3, which is used by the town for the purpose of a recreational field, to Northeast Solite Corporation for 2006 and 2007 in the amount of \$20,103.00 from the fund balance to account B 7110.432 per the town accountant.
