The meeting was called to order at 7:15 p.m. with the Pledge of Allegiance and the following members were present:

PUBLIC COMMENT PERIOD:

Josh Randall – spoke on the historic designation of Winston Farm. Mr. Randall's entire statement is on file at the Town Clerk's Office.

Marti Randall – been doing research on Winston Farm for two years. Compiled so much evidence to prove Winston Farm should be designated. Wynkoop House was saved and designated quick without extensive research, but now we know that it was the only fort. Designation does not infringe on property rights.

Frederick Cousin – lives on Claires Road near the Esopus Creek Road, which is a very narrow and winding road. Would like lines painted on the road for safety. Also, recreation vehicles on the creek are a concern; very noisy and would like ordinance to deter disturbance.

Rachel Drayer – presented the Town Board with a petition to ban smoking at sporting events at Cantine Field.

Barry Benepe – would like to complete historic designation at Winston Farm and the three parcels would be complete and protected. This is an opportunity to preserve history.

Stephen Shafer – hopes Town Board designates the Winston Farm tonight.

Terence Gilbride – represents Schaller Family. What has changed since last year to change the Town Board's mind – nothing. There is not enough notoriety to designate. This was Mr. Winston's home for a portion of his life. There would be a significant reduction in taxes that the town would receive if designated. Asking the Town Board to vote it down now – finally, forever.

RESOLUTION

BY THE TOWN BOARD OF THE TOWN OF SAUGERTIES CONCERNING THE HISTORIC DESIGNATION OF WYNKOOP/SAUGERTIES/WINSTON FARM

WHEREAS, certain resolutions were duly adopted by the Historic Preservation Commission of the Town of Saugerties and a first series of public hearings were held on September 5, 2005, and concluded on February 20, 2006 and a second series of public

hearings were held on October 16, 2006 and concluded on April 30, 2007 to hear all interested parties on a proposed historic designation of the Wynkoop/Saugerties/Winston Farm; and

WHEREAS, the Historic Preservation Commission previously unanimously voted in favor of a historic designation on April 17, 2006, and the Town Board of the Town of Saugerties voted to disapprove said historic designation without prejudice; and

WHEREAS, the Historic Resources Commission adopted Rules and Regulations for the Conduct of Business on September 18, 2006; and

WHEREAS, the Historic Resources Commission previously designated itself as Lead Agency under the State Environmental Quality Review Act (SEQRA) and determined that the proposed historic designation of the Wynkoop/Saugerties/Winston Farm was a Type II Action under 6 NYCRR Part 617.5(32); and

WHEREAS, the Historic Preservation Commission voted in favor a historic designation on June 18, 2007, for the Wynkoop/Saugerties/Winston Farm and the Town Board of the Town of Saugerties has forty five (45) days to disapprove or modify said historic designation pursuant to Section 4.C of the Town's Historic Preservation Ordinance (Local Law No. 3 of 2004) duly adopted by the Town Board of the Town of Saugerties on March 24, 2004, and filed on April 8, 2004 with the New York Department of State; and

WHEREAS, the Town Board of the Town of Saugerties received a copy of a historic designation letter (and copies of the supporting documentation attached thereto) dated June 28, 2007, written by Barry Benepe, Chairman of the Historic Preservation Commission to Ralph F. Schaller, the representative of the Wynkoop/Saugerties/Winston Farm; and

WHEREAS, the members of the Town Board of the Town of Saugerties reviewed said letter and the supporting documentation attached thereto;

NOW, THEREFORE, the Town Board of the Town of Saugerties, after due deliberation, finds it in the best interest of said town to disapprove the June 18, 2007, historic designation of the Historic Preservation Commission concerning Wynkoop/Saugerties/Winston Farm.

RESOLUTION AUTHORIZING ADOPTION BY THE TOWN BOARD OF THE TOWN OF SAUGERTIES OF LOCAL LAW NO. 3 OF THE YEAR 2007

WHEREAS, a resolution was duly adopted by the Town Board of the Town of Saugerties for a public hearing to be held by the Town Board on May 16, 2007 at 5:30 p.m. at the Frank D. Greco Senior Citizens Building on Market Street, in the Village of Saugerties, New York, to hear all interested parties on a proposed Local Law entitled "A Local Law Enacting Real Property Tax Exemption for Historic Property that is Altered or Rehabilitated in Accordance with Local Historic Preservation Laws, pursuant to Section 444-a of the Real Property Tax Law", and

WHEREAS, notice of said public hearing was duly advertised in the Saugerties Times, the official newspaper of the Town of Saugerties on May 3, 2007, and

WHEREAS, said public hearing was duly held on May 16, 2007 at 5:30 p.m. at the Frank D. Greco Senior Citizens Building, Market Street, Saugerties, New York and all parties

in attendance were permitted an opportunity to speak on behalf of or in opposition to said proposed local law, or any part thereof, and

WHEREAS, this local law would enact a real property tax exemption for historic property that is altered or rehabilitated within the Town of Saugerties, in accordance with Local Historic Preservation Laws, and

WHEREAS, the Town Board of the Town of Saugerties, after due deliberation, finds it is in the best interest of the Town of Saugerties to adopt said local law.

NOW, THEREFORE, BE IT RESOLVED, that the Town Board of the Town of Saugerties hereby adopts said Local Law No. 3, entitled "A Local Law Enacting Real Property Tax Exemption for Historic Property that is Altered or Rehabilitated in Accordance with Local Historic Preservation Laws, pursuant to Section 444-a of the Real Property Tax Law', a copy of which is attached hereto and made a part of this resolution, and be it further

RESOLVED, that the Town Clerk be and she hereby is directed to enter said Local Law in the minutes of this meeting and in the Local Law Book of the Town of Saugerties and to give due notice of the adoption of said Local Law to the Secretary of State of the State of New York. The Town Clerk shall also file a copy of the Local Law with the State Board of Assessment and with the Assessor of the Town of Saugerties.

TOWN OF SAUGERTIES, ULSTER COUNTY, NEW YORK LOCAL LAW NO. 3 FOR THE YEAR 2007

"A Local Law Enacting Real Property Tax Exemption for Historic Property that is Altered or Rehabilitated in Accordance with Local Historic Preservation Laws, pursuant to Section 444-a of the Real Property Tax Law"

Be it enacted by the Town Board of the Town of Saugerties as follows:

Section 1. In accordance with the authorization of subdivision 1 of Section 444-a of the Real Property Tax Law, an exemption from real property taxation by the Town of Saugerties is granted for historic property that is altered or rehabilitated subsequent to the date of this local law, as described in Section 444-a of the Real Property Tax Law.

In accordance with the authorization of subdivision 2 (a) of Section 444-a of the Real Property Tax Law, historic property shall be exempt from taxation to the extent of any increase in value attributable to such alteration or rehabilitation in accordance with the following schedule:

Section 3. This local law shall take effect immediately upon filing and acceptance by the Secretary of State.

WHEREAS, Town Law Section 24-a provides that the Town Board may adopt a resolution to provide that the term of office of any elective Town Official shall be four years, provided such resolution is submitted to the qualified electors of the town for their approval or disapproval at the next biennial town election; and

WHEREAS, the Town Board desires to adopt and approve such a resolution to increase the term of office of the Town Clerk from two years to four years.

NOW, THEREFORE, BE IT

RESOLVED, that the following proposition be presented for consideration by the electors of the Town of Saugerties, pursuant to the provisions of the Town Law at the next biennial town election to be held on November 6, 2007 viz: "Shall the term of office of the Town Clerk of the Town of Saugerties be increased from two years to four years"; and it is further

RESOLVED, that if the foregoing proposition be adopted by a majority of the electors of the town, that the term of office of the Town Clerk shall be increased from two years to four years, to be effective to elections occurring subsequent to the approval by the voters of the proposition to increase the term; and it is further

RESOLVED, that the Town Clerk shall give notice of such proposition at the expense of the town at least ten days prior to the election, by the publication of a notice in the official newspaper of the town published in the Town of Saugerties and by the posting of such notice on the sign board of the town setting forth in full the proposition to be voted upon and specifying that the proposition will be submitted at the biennial town election to be held on November 6, 2007.
