Summer Day Camp registrations are being accepted at Town Clerk's Office. August 6 – 10 will be the Mets Academy Camp. Thanks and appreciation to police officers who helped during the last snowstorm.

BOARD COMMITTEE REPORTS:

Councilman Leighton – gave report from Water & Sewer Department, which is on file in the Town Clerk's Office. Will be setting up informational meetings for public regarding MS-4.

Councilwoman Thornton – TV 23 committee met with town and village police officers to get emergency information out to the residents. The plan is to link together to get information out immediately. CPC met with Chazen representatives recently and committee has been working tirelessly to finish zoning law. Historic Preservation will meet on the 3rd Monday continuing the Winston Farm Public Hearings. Library Board met to discuss expendable trust. CAC is doing an open space inventory. Bio-diversity group is working very hard; ten month project.

Councilman Costello – ordered lap tops for police cars and scanner with help of Officer Fallon in securing \$90,000.00 plus for department.

Councilwoman Campbell – Ethics committee has completed first draft for April meeting, has been a good working group. Planning Board will meet April 17, 2007. ECD, Vernon Benjamin and self will be liaisons with CPC. Building Department is doing what they should with regard to property of Mr. Fowler on Route 9W. Councilwoman Campbell read a letter from Department of State dated March 25, 2007 verifying the job by the building department.

Motion made by Councilwoman Thornton, seconded by Councilman Costello to approve the following resolution, as read, to request designation of the Esopus Creek Conservancy trails as part of the Hudson River Greenway Trail System.

REQUEST FOR GREENWAY TRAIL DESIGNATION OF THE ESOPUS CREEK CONSERVANCY TRAIL BY THE TOWN OF SAUGERTIES

WHEREAS, Article 44 of the Environmental Conservation Law (ECL) directs the Greenway Conservancy for the Hudson River Valley, Inc. to designate a Hudson River Greenway Trail, and

WHEREAS, the Esopus Creek Conservancy manages, owns or holds an easement for a community trail which will enhance the opportunity the public has to appreciate and

support the preservation of the historic, scenic, cultural, recreational and natural resources along the Greenway Trail, and

WHEREAS, the Esopus Creek Conservancy requests that five miles of the Esopus Creek Conservancy Trail be designated as a riverside/countryside corridor/connector trail as part of the Hudson River Greenway Trail System,

NOW, THEREFORE BE IT RESOLVED AS FOLLOWS:

The Town Board of the Town of Saugerties requests designation of the Esopus Creek Conservancy Trails as part of the Hudson River Greenway Trail System.

Vote: Adopted – 5 Yes

Motion made by Councilman Leighton, seconded by Councilman Costello to approve the following resolution, as read, to allow the Town Supervisor, Greg Helsmoortel, to enter into an agreement with Ulster County for the purpose of implementing Phase II Stormwater Requirements (MS4).

WHEREAS, the town is located in an area of Ulster County that is subject to Stormwater Phase II Implementation (MS4) requirement; and

WHEREAS, Ulster County has developed a cooperative model that will allow participating municipalities to meet the minimum requirements for MS 4 compliance; and

WHEREAS, the town is highly desirous of utilizing cooperative approach to improve water quality and meet MS4 compliance.

RESOLVED, the Supervisor is hereby authorized to enter into an intermunicipal agreement with Ulster County for MS4 compliance and water quality improvement when approved as to form by the town attorney.

Motion made by Councilman Costello, seconded by Councilman Leighton to allow the Town Supervisor, Greg Helsmoortel, to sign and submit the engagement letter/contract between the Town of Saugerties and the accounting firm of Pattison, Koskey, Howe and Bucci for the town's annual audit.

Discussion: Supervisor Helsmoortel explained that since we have a HUD office in our town, we need to have an audit every year.

Motion made by Councilman Thornton, seconded by Councilman Leighton to set Public Hearing for May 16, 2007 at 5:30 p.m. for the proposed local law enacting Real Property Tax Exemption for Historic Property that is altered or rehabilitated in accordance with local Historic Preservation Laws.

Motion made by Councilman Thornton, seconded by Councilman Leighton to hire Anastasia Redman as Public Access Coordinator at the rate of \$15,000.00 per year effective April 15, 2007.
