PUBLIC COMMENTS:

Patti Kelly – expressed anger at waiting two hours for the workshop meeting to start, which was just an Executive Session. Did personnel matters include discussion of unpaid volunteer positions? The new position of Budget Officer – what are the qualifications and experience of this person, is there a job description? Questioned hiring Bonacic's Law firm, conflict with him being State Senator and why would that hourly rate be higher than other law firms.

Doug Pettit – attended the meeting with Larry Regan (Dickerson's Keep) and he stated that he would maintain the road at no cost to the town, now that has changed with no reason given. Would like someone to find out about this.

Peter Petramale – congratulations to Kelly Myers. Would like an up-date on the Dickerson's Keep project. Councilman Bruno said that he called the Chief in Fishkill and they devote a lot of time to domestics and drug related instances near the project.

Gaetano Ciarlante – congratulations to Kelly. Dickerson's Keeps' funding is not approved by the state, the Town Board should give a deadline and wanted to know if Councilman Costello sent a letter. Councilman Costello responded that there is a lobbying black-out and he did not see or send a letter. Supervisor Myers said she called the attorney and left a message, it is important that we follow the law. Ms. Ciarlante asked that since Mr. Vaganelis was taken off this project because of a conflict, will he repay the town the money he was paid regarding Dickerson's Keep?

Kolton Chubb – in Cafaldo Park we are paying a Bond for the pumping station, how will Dickerson's Keep affect this.

Jim Uhl – Dickerson's Keeps' numbers do not add up compared to apartments he rents – who will be able to afford these. Since the funding has been pulled, the town should get a performance bond and they may not get funded by HUD.
