Eleanor Redder from the CAC read a letter stating Phase I Stormwater Report has been completed by Steve Winkley and has been sent on to Dennis Doyle at the Ulster County Planning Board. Phase II is in the preliminary stage. Also, relayed that the CAC would like a moratorium placed on all residential building until complete water study is done.

Steve Hahn from SAGA was informed that the Assessor has given a proposal to work together and hopefully everything will work equally for everyone. Also, handed out summary of town wide re-evaluation.

Greg Chorvas reported on the key swipe system speaking with Jim Beaver and Diane Bietel from the county. They would be willing to set-up system for the town and able to purchase main components through county bid. We would get all the benefits at a fraction of the cost.

A moment of silence was observed for the passing of Joan Feldmann, former Ulster County Legislator and Saugerties resident.

PRIVILEGE OF FLOOR:

Karlyn Elia – Saugerties has a long tradition of honoring and supporting their fellow citizens who have served our country during both war and peace. We are currently in the process of honoring those who served and died during the 20th century conflicts. It was originally thought that 66 men from Saugerties died in these conflicts. Now, as a result of extensive research accomplished with the help of the Ulster County Veteran's Service Agency and through microfilm archives, four more men have been found and will be placed on the memorial. The memorial to these 70 men is near completion and will be erected at the Donlon Park, near the Civil War Memorial. The unveiling date has not yet been set.
