Motion made by Councilman Schirmer, seconded by Councilwoman Thornton to approve the appointment of Supervisor Greg Helsmoortel, Deputy Supervisor James Bruno, Highway Superintendent Doug Myer, Police Chief Joseph Sinagra, Buildings and Grounds Superintendent Greg Chorvas, Building Inspector Alvah Weeks, Water & Sewer Superintendent Mark Resso and Special Operations Coordinator Vernon Benjamin as Town of Saugerties representatives on the Core Planning Group established in conformance with the updating of the 2009 Ulster County Multi-Jurisdictional Hazard Mitigation Plan requirements in compliance with the Disaster Mitigation Act of 2000.
