Motion made by Councilman Costello, seconded by Councilman Schirmer to approve the hiring of the following three reserve officers (volunteers) with an effective start date of November 1, 2014, Andrew D. Armour, Tyler R. Downes and James C. Simmons per the recommendation of the Chief of Police.

Motion made by Councilwoman Thornton, seconded by Supervisor Helsmoortel to allow the Supervisor to enter into a no cost contract with Ulster County known as the Safe Routes to School Action Plan to provide safe routes to local schools (i.e. sidewalks).
