BOARD COMMITTEE REPORTS:

Councilman Leighton – working with Alvie Weeks, Paul Economos and George Redder on unsafe building laws. Supervisor Myers added that this is a great thing to do.

Councilwoman Thornton -12 new students for TV23 = 48 volunteers. Historical Society is looking for Kiersted Family members to attend the reunion. CAC meets May 17; CPC meets every Tuesday night.

Councilman Costello – Relay for Life and Wing Fling will be held this weekend at Cantine. Would like to compliment Highway Department on paving at the Ice Rink and work done in Glasco. Greg Chorvas received \$2,200.00 in scrap metal so far. Congratulations to J & M Stables for horse competing in Kentucky Derby.

Councilman Bruno – Historic Preservation Commission held the Stone House Tour this past weekend, 140 tickets were sold – great success.

MOTIONS & RESOLUTIONS:

Motion made by Supervisor Myers, seconded by Councilwoman Thornton to approve the proclamation, as on file, recognizing May 19 and 20, 2012 as Relay for Life days in Saugerties.

Discussion: Councilwoman Thornton added that Grand Marshall Werner Hegner was present at the meeting, congratulations!

Vote: Adopted – 5 Yes

Motion made by Supervisor Myers, seconded by Councilman Leighton to adopt Local Law #2 of 2012 Prohibiting the Sale, Possession or Distribution of Drug Paraphernalia in the Town of Saugerties.

Discussion: Supervisor Myers added that the law was reviewed by DA Holley Carnright and approved. We have had positive support of the law.

Vote: Adopted – 5 Yes

Motion made by Councilman Bruno, seconded by Councilman Costello to approve the resolution, as on file, authorizing the Supervisor to enter into permanent road easements for access to the Kate Yaeger Road and bridge under contract TSA-123; FEMA 4020. Discussion: Supervisor Myers said it is important to continue work while FEMA money is still available.

Vote: Adopted – 5 Yes

Motion made by Councilman Costello, seconded by Councilman Bruno to accept the resignation of Deborah Rosa, part-time dispatcher, effective June 10, 2012.

Discussion: Councilman Costello would like to thank her for her service.

Vote: Adopted – 5 Yes

Motion made by Supervisor Myers, seconded by Councilman Bruno to adopt the amended M&T Treasury Management Services Agreement, as on file, to add the town's HRA (health insurance) account to the list of on-line accessible accounts, per the Town Accountant.

Vote: Adopted – 5 Yes

Motion made by Supervisor Myers, seconded by Councilman Bruno to amend the motion of April 18, 2012 regarding naming the Saugerties Town Hall the Gregory L. Helsmoortel Town Hall (as the town hall was already named in 2001 after Col. Roger Donlon) to naming the renovated space that houses the Building Department and the new Police Department addition the Gregory L. Helsmoortel wing at Town Hall. Discussion: Councilmen Costello and Leighton met with Col. Donlon this afternoon and he said his high point was having the Legion Park named after him – feels he has been honored enough. He would want all men and women who served from Saugerties honored. Councilwoman Thornton talked with Marie Post and she can't explain why no sign or recognition was erected after the 2001 motion. She supports town hall named after Greg Helsmoortel and Veteran wing be designated for Col. Donlon. Councilman Costello enjoyed meeting with Col. Donlon and he is still doing good works. Important to reach across and all do good work. What we did for Greg was out of honor for what he did to achieve our town hall. Councilman Bruno said the Association of Towns said the original vote is valid. If Greg were here, he would want what was right. Supervisor Myers brought the motion on the agenda and it is important to follow through and come to a good compromise. Councilman Costello said its difficult with different legal opinions, Supervisor Myers said they need a definitive answer. Councilman Leighton also said that the 2001 motion's two no votes wanted the town hall to be named after all Veterans.

Vote: Defeated – 2 Yes (Councilmen Costello, Leighton and Councilwoman Thornton voting No)

Motion made by Councilwoman Thornton, seconded by Councilman Leighton to approve a donation of \$1,500.00 to the Saugerties Artists Studio Tour scheduled for August 11 & 12, 2012.

Discussion: Councilwoman Thornton added that it is the 10^{th} Anniversary – 40 artist participating and it brings in tremendous traffic to the town. Supervisor Myers said that the town board is asked frequently to give donations to events and we will coming up with a policy shortly.

Vote: Adopted – 5 Yes

Motion made by Supervisor Myers, seconded by Councilman Bruno to enter into Executive Session regarding matters leading to the appointments, employment, promotion, demotion, discipline, suspension, dismissal or removal of a particular person or corporation at 9:25 p.m., carried.

Motion made by Councilman Bruno, seconded by Supervisor Myers to exit Executive Session at 11:00 p.m. and resume Town Board Meeting, carried.

Motion made by Supervisor Myers, seconded by Councilwoman Thornton to set a Public Hearing for June 6, 2012 at 5:00 p.m. to extend the term of the Highway Superintendent from a two year term to a four year term.*

Vote: Adopted – 5 Yes

Motion made by Councilman Bruno, seconded by Councilwoman Thornton to set a Public Hearing for June 6, 2012 at 5:15 p.m. to extend the term of the Supervisor from a two year term to a four year term.*

Vote: Adopted – 5 Yes

Motion made by Councilman Costello, seconded by Supervisor Myers to appoint Suzanne Filak as interim Receiver of Taxes effective June 29, 2012 through December 31, 2012.

Vote: Adopted – 5 Yes

Motion made by Councilwoman Thornton, seconded by Councilman Bruno that upon retirement of the current Receiver of Taxes, authorize the Supervisor to hire an independent audit of the records.

Vote: Adopted – 5 Yes

Motion made by Councilman Bruno, seconded by Councilman Leighton to adjourn Town Board Meeting at 11:10 p.m., carried.
