### PRIVILEGE OF FLOOR:

Maraleen Manors-Jones talked regarding the pollinator initiative, protector of wildlife, bees and butterflies. Asking community to please not use pesticides and wants to save the milkweeds for pollinating.

Alvah Weeks, Building Inspector – spoke on outdoor wood boilers that rules have been followed. Other towns have tried to place more laws on these, but cannot enforce if they were installed before 2011.

Motion made by Councilman Costello, seconded by Councilman Bruno to approve hiring Samantha Shultis as a part time Dispatcher at a rate of pay of \$16.20 an hour, per the Chief of Police.

Motion made by Councilman Bruno, seconded by Supervisor Helsmoortel to approve executing the Quit Claim Deed, as on file, between the Town of Saugerties and Buell & Cline pertaining to Ralph Vedder Road.

Vote: Adopted – 5 Yes

Motion made by Supervisor Helsmoortel, seconded by Councilman Schirmer authorizing Superintendent of Highways Douglas Myer to proceed with the following: declare a surplus and solicit bids for the sale of the following truck – one 1978 Osh Kosh plow truck with sander and plow attachments, model #P2323-1, serial #17091. Further, if the highest bid received for this truck is less than the current reimbursement rate for metal salvage reclamation, Superintendent Myer will reject the bid and turn in said truck for reclamation.
