Councilwoman Thornton – CAC chairman, Brian Sawchuk will begin open space inventory; TV23 Open House will be January 26, 2008 from 11:00 am to 2:00 pm; Ulster County Youth Bureau nominees for youth awards will be received for grades 4-6, 7-9 and 10-12 and presented in May.

Councilman Costello – court clerk addition is 90% complete; renovation done with bathroom at Highway Department; Glasco Mini Park meeting to discuss Phase 3; and Terry Valk will start energy efficiency at senior center.

Councilwoman Campbell – Peter Fairweather and EDC gave a nice presentation, next meeting will be January 28, 2008 at 5:00 p.m.; PACT will meet January 31, 2008; CT Male will hold another day of training, which we are applying for another grant with GIS and it is due February 1, 2008. Finally, received another draft of zoning law and we will hold a third Public Hearing.

Discussion: Councilman Costello added that negotiations were just completed and it was very productive.

Motion made by Councilman Costello, seconded by Councilman Leighton to approve the 2008 contract, as on file with the Town Clerk for DWI/DWAI dispositions in the Town of Saugerties Court between the Town of Saugerties and the County of Ulster.

Vote: Adopted – 5 Yes

Motion made by Councilwoman Thornton, seconded by Councilman Costello that be it resolved that the Town Board would like to enter into the minutes the approval of the resolution, as on file with the Town Clerk, in support of an application to the Division of Housing and Community Renewal for the Saugerties Scattered Site Housing Rehabilitation Program.

Discussion: Councilwoman Thornton stated this is \$500,000.00 grant with Village of Saugerties; Councilman Costello added also in conjunction with RUPCO.

Vote: Adopted – 5 Yes

Motion made by Supervisor Helsmoortel, seconded by Councilman Costello to approve the bid for abrasive screenings, washed to Peckham Industries, Catskill, NY per the Highway Superintendent, to be used by the Town of Saugerties, the Village of Saugerties and the Saugerties Central School District per ton pick-up as per bid dated January 22, 2008 and as on file with the Town Clerk

Discussion: Supervisor Helsmoortel explained that Mr. Ellsworth included the village and school district so they wouldn't have to go to bid separately.

Discussion: Supervisor Helsmoortel added that NYS has cut back funding and we are glad to help.

Vote: Adopted - 5 Yes

Motion made by Councilwoman Campbell, seconded by Councilman Leighton to set a Public Hearing for the most recent draft of the Zoning Law for the Town of Saugerties for February 21, 2008 at 6:00 p.m. at the Senior Center.

Discussion: Supervisor stated that changes have been made per public in-put and maps have been changed.

Vote: Adopted - 5 Yes

Motion made by Councilwoman Thornton, seconded by Councilman Costello to approve the audit/examination of the town's court records, which was done by the town's accountant per the request of the State of New York Unified Court System.

Discussion: Supervisor Helsmoortel added that the audit went well and in compliance with the State.

Vote: Adopted – 5 Yes

Motion made by Councilman Leighton, seconded by Councilman Costello to allow the Supervisor to sign the proposal for Phase 1A Archeological Assessment for the Kings Highway Water and Sewer District.

Vote: Adopted – 5 Yes

Motion made by Councilman Leighton, seconded by Councilman Costello to allow the Supervisor to sign the joint application for Permit for a Public Water Supply and Water Supply Application form for the Kings Highway Water and Sewer District.

Vote: Adopted – 5 Yes

Motion made by Councilman Costello, seconded by Councilman Leighton that be it resolved that the Town Board would like to enter into the minutes the approval of the resolution, as on file with the Town Clerk, for the establishment of the Village Drive Lighting District.

Discussion: Councilman Costello said they are hopeful to get lights turned on by spring. Vote: Adopted – 5 Yes

Motion made by Councilman Costello, seconded by Councilwoman Campbell to allow Detective Hank Mirabella to carry over 2007 clothing allowance to be used by January 17, 2008 with the understanding that this does not establish past practice.

Motion made by Supervisor Helsmoortel, seconded by Councilman Leighton to designate Peg Nau, the Town of Saugerties Delegate at the Annual Business Session of the Association of Towns of the State of New York to be held in NYC on February 20, 2008. Vote: Adopted -5 Yes
