PRIVILEGE OF FLOOR:

Jeremy Rushkoski & Steve Wehr: 2 EV's for the police department – gave a presentation for the benefits of applying for grants.

Ulster County Commission for Reapportionment: Commissioners Kathleen Waithe & Regis Obijski outline charge of commission and input from meeting attendees regarding our county legislative districts that retain 23 districts in Ulster County but boundaries may change.

PUBLIC COMMENT PERIOD:

Kelly Miller – lived here whole life, Hope Antonelli is anything but a racist. Open door policies, if a student wants an assignment changed, it happens. Only snap-shot of assignment, it was not the whole context; libel and slander are wrong. Councilman Schoonmaker should resign as a board member because he misused his power.

Keith Kehoe – Veteran and embarrassed for the school board and union. Councilman Schoonmaker is shallow and should resign. Hope Antonelli should be commended for having students think outside the box.

Bridget Maldarelli – in school we had all different views and assignments, kids these days are pampered. If you don't agree with Justine, you are automatically a racist.

Deacon David Edwards – Mrs. Antonelli is not a racist. Have gone through numerous changes but Mrs. Antonelli was always there. God is forgiving and John Schoonmaker should ask for forgiveness. Mrs. Antonelli feels threatened.

Andrew Farrell – agrees with all regarding Mrs. Antonelli. On a different note, we have an AirBnB but are not ghost renters; we live here. Would like to talk to the town board and see if changes are coming soon. Supervisor Costello said to stay engaged because the board is at the very beginning of talks with this, it is a balancing act. Mr. Farrell continued that he depends on the income so it is fearful. Councilman Ivino added that the building department is inundated with requests of tiny homes, AirBnB, etc. need things in place to make the town run smooth and without incident.

John McFeely – signed a petition to remove John Schoonmaker, losing career move by taking sides.

Lauren Ruberg – taxpayer and former teacher. John Schoonmaker, what has prompted you to go against another public servant? Instead of speaking directly to the teacher or superintendent, went to facebook instead. We are a town of hardworking public servants and could not sit in silence.

Raymond Williams – sent email to SHS administrators; she is amazing teacher, promotes positivity and is not racist. Thank her for bringing forth hard subjects. College professor gave same assignment. This town lives in harmony until Justine came in to this town.

Nina Scheinbauer – has several clients with experience with SHS. Proud of John Schoonmaker for saying something about this subject. The assignment could have been worded differently.

Jessica Lewoc – teacher was degraded without discussion; assignment does not infer racism, look at the big picture. Teacher immediately reached out to the student and family.

Bobbi Jo Weber – daughter is afraid of protestors, afraid to go back to school.

Supervisor Costello said the town board does not have authority over SHS and has not taken a position on this; there is freedom of speech and due process.

Karen Sasso – if no governing authority, why can John Schoonmaker speak out? In violation of his position and he should not represent our town.

Councilman Schoonmaker – this was a personal statement and not from the town board; had an issue with a statement at the end of the assignment.

SUPERVISOR'S COMMENTS: we removed two motions from the agenda tonight regarding accepting bids for roof replacements because we would like to explore financing options. Congratulations to Sawyer Savings Bank for their 150th Anniversary. Saugerties is listed in a NY Times article.
