Town of Ulster Supervisor Jim Quigley spoke about the Niagara Bottling Works from Ontario, Canada building their business in the Town of Ulster on a 57 acre tract of land located at the old IBM property. There will be a 415,000 sq. ft. building bringing 120 jobs. Mr. Quigley extended an invitation to the town board to visit the site.
