They have been a tremendous help to the community and thank you for all your time. The Chief will be restructuring and will hold an informational meeting for the public in early January.

Councilman Bruno – Merry Christmas and Happy New Year!

Chief Sinagra – would like to thank the town board for the raise in salary but will respectfully decline since officers have not received a raise. Has a Contract and it states when a raise will be given.

MOTIONS & RESOLUTIONS:

Motion made by Supervisor Helsmoortel, seconded by Councilman Costello to approve the salaries, as approved in the budget, as listed for 2015 for elected officials: Supervisor at

\$35,000.00 (unchanged), Town Board Members (4) at \$10,000.00 each (unchanged), Receiver of Taxes at \$37,758.24, Town Clerk at \$42,000.00 (position has not received a raise in four years), Highway Superintendent at \$65,000.00 and Court Justices (2) at \$28,250.00 each. Vote: Adopted – 5 Yes

Motion made by Councilman Schirmer, seconded by Councilman Costello to approve the salary, as approved in the budget for 2015 of \$70,000.00 for the Assessor.

Discussion: Councilman Schirmer said the Assessor has foregone a raise for a couple of years.

Vote: Adopted – 5 Yes

Motion made by Councilman Costello, seconded by Councilman Bruno to approve the salary, as approved in the budget for 2015 of \$65,321.88 for the Superintendent of Parks & Buildings.

Vote: Adopted – 5 Yes

Motion made by Councilman Bruno, seconded by Councilman Schirmer to approve the salary, as approved in the budget for 2015 of \$60,283.00 for the Building Inspector/Zoning Administrator.

Vote: Adopted – 5 Yes

Motion made by Councilwoman Thornton, seconded by Councilman Costello to approve the salary, as approved in the budget for 2015 of \$54,872.00 for the HUD Section 8 Program Supervisor.

Discussion: Supervisor Helsmoortel added that this is provided by the federal government and is reimbursed.

Vote: Adopted – 5 Yes

Motion made by Councilman Costello, seconded by Councilman Bruno to approve the pay rate of \$12.50 per hour for Samantha Wamsley as part time per diem Clerk per the Town Clerk and Highway Superintendent.

Vote: Adopted – 4 Yes (Supervisor Helsmoortel abstained)

Motion made by Supervisor Helsmoortel, seconded by Councilman Bruno to hire Donna Shultis as clerk for Receiver of Taxes at a rate of \$12.00 per hour, effective December 17, 2014 per the Tax Receiver.

Vote: Adopted – 5 Yes

Motion made by Councilman Bruno, seconded by Councilman Costello to approve Kevin Brown as an assistant building inspector, part-time on an as needed basis at his current rate of pay, effective immediately.

Discussion: Councilman Bruno said that Kevin went for training and will be an asset.

Vote: Adopted – 5 Yes

Motion made by Councilman Costello, seconded by Councilman Bruno to approve the resignation of part time police officer John Larrabee, effective December 1, 2014.

Vote: Adopted - 5 Yes

Motion made by Councilman Costello, seconded by Councilman Bruno to approve the resignation of volunteer part time reserve police officer Thomas Tulimero, effective December 10, 2014.

Vote: Adopted – 5 Yes

Motion made by Supervisor Helsmoortel, seconded by Councilman Costello to approve the health insurance eligibility policy, as on file, effective February 1, 2015.

Discussion: Supervisor Helsmoortel added that this is clearing up some language and raising hours to be able to receive benefit. Also, if two spouses are employed and one receives health benefits for the family, the other will not receive a buy-out.

Vote: Adopted – 5 Yes

Motion made by Supervisor Helsmoortel, seconded by Councilman Schirmer to approve the contract, as on file, for care and boarding of canines between the Town of Saugerties and the Town of Kingston.

Vote: Adopted – 5 Yes

Motion made by Councilman Schirmer, seconded by Councilman Costello to approve the agreement, as on file, between the Town of Saugerties and Diaz Memorial Ambulance Service. Discussion: Councilman Schirmer added that the district contracts with Diaz to provide service. Councilman Costello stated that we are very fortunate to have the ambulance district.

Vote: Adopted – 5 Yes

Motion made by Councilman Costello, seconded by Councilman Bruno to approve the 2015 DWI Task Force Agreement, as on file, between the Town of Saugerties and Ulster County. Vote: Adopted – 5 Yes

Motion made by Councilman Costello, seconded by Councilman Schirmer to hire Martin Monaco as a part time school crossing guard in the absence of Ann Ward, effective December 10, 2014 at the rate of \$12.25 an hour.

Vote: Adopted – 5 Yes

Motion made by Councilman Costello, seconded by Councilman Schirmer to promote Lieutenant Stephen Filak to Captain (no overtime) will receive an additional \$3,500.00 and will no longer be in the CBA or Union member.

Discussion: Councilman Costello explained that Mr. Filak will become salary and compliment the Chief. This also saves a lot of money in overtime.

Vote: Adopted – 5 Yes

Motion made by Councilman Bruno, seconded by Councilman Costello to set a public hearing of 6:30 p.m. on January 21, 2015 pertaining to Old Route 212 Stop Sign.

Vote: Adopted – 5 Yes

Motion made by Supervisor Helsmoortel, seconded by Councilman Bruno to enter Executive Session regarding matters leading to the appointment, employment, promotion, demotion, discipline, suspension, dismissal or removal of a particular person or corporation at 8:15 p.m., carried.

Motion made by Supervisor Helsmoortel, seconded by Councilman Costello to exit Executive Session and adjourn Town Board Meeting at 8:30 p.m., carried.
