Tom Melville – spoke on behalf of kayakers regarding the boat launch at Malden Mini Park. Need a ramp that will not damage the kayaks and be safe for the individuals.

PUBLIC COMMENT PERIOD:

John Voerg, Bruin Drive – flooding conditions getting worse in Blue Mountain Park; deteriorating landscaping and leach field. Now flooding invades inside of home. Mr. Ellsworth agreed this also creates unsafe intersection in the park. Supervisor Helsmoortel

added that the town engineer was at the site last week and will provide estimate to fix drainage problem.

Motion made by Councilwoman Campbell, seconded by Supervisor Helsmoortel to approve the hiring of Jeremy Kane for the position of Town of Saugerties Gatekeeper for an annual salary \$42, 500.00 pending a six month probationary period and civil service approval.

Vote: Adopted - 3 Yes (Councilpersons Leighton & Thornton absent)

Motion made by Councilman Costello, seconded by Supervisor Helsmoortel to hire Kevin M. Mayone as a summer employee/laborer for the Water & Wastewater Department as per the recommendation of the Water & Wastewater Superintendent, to start the week of June 25, 2007 at a rate of \$8.00 per hour.

Motion made by Councilwoman Campbell, seconded by Councilman Costello to allow the Town of Saugerties Supervisor, Greg Helsmoortel, to file an application for funds from the Hudson River Estuary Program in accordance with the provisions of the Hudson River Estuary Management Act of the New York State Department of Environmental Conservation in an amount not to exceed \$25,000.00 and upon approval of said request to enter into and execute a project agreement with the Hudson River Estuary Program for such financial assistance to the Town of Saugerties for the Town of Saugerties Open Space Inventory Project.
