Doug Myer – on last month's agenda, a road dedication motion was tabled. This project has been on-going for 16 years. Town Engineer Joe Mihm spoke that the road still has four issues that need to be resolved; the stormwater drainage has six issues that need to be resolved.

Greg Chorvas – Christmas week revenue at the ice rink for public skate time was \$23,400.00 with 2,605 individuals using the rink. Empire Games torch relay came through Saugerties and there will be 70+ participants at the Games.

Claudia Andreassen – new Court Clerk started two weeks ago and is doing well. Markertek donated equipment to hear better on the bench.

BOARD COMMITTEE REPORTS:

Councilman Andreassen – welcomed students to the board meeting and extended an invitation for them to be at a Planning Board meeting.

Councilwoman Thornton – town and village CPC is an insightful group and hope to have plan updated by June. CPC has recommended expanding types of businesses to go in Kings Highway and Malden Turnpike and by Vertis building. Lifespring has their spring enrollment going on now.

Councilman MacIsaac – Climate Smart Community is working on certification. Spectrum is wiring Wilhelm Road and Charles Smith Road. Procurement Policy states two verbal bids needed over \$500.00, this needs to be addressed.

Councilman Schoonmaker – please submit application for Animal Shelter to get pre-approved. New scholarship for \$1,000.00 will be available from Shout Out Saugerties. HPC will be at Bigelow Park on February 15th at 10:00 a.m. to give a history of the park; there will be an Open House at the Legion at 11:00 a.m. Mark Sullivan Smith has decided to step down from the committee. Thank you for your time! Marjorie Block is getting rack cards out for the Tourism Committee and the new Discovery books are being worked on.
