Mr. Weeks stated that there is a problem with the Zoning Law – nothing shall prevent any person from keeping farm animals. There are three large pigs on ¼ acre lot in Barclay Heights; tickets have been issued for emitting odors. Health Department walks away from animal issues. Councilwoman Campbell reiterated that we do support the Right to Farm Law but don't want neighbors to drive each other crazy. Changes need to be made with Municipal and Zoning Law. Mr. Weeks will meet with Town Attorney Greco and possibly a farm representative (Skip Arthur) and the Chief of Police.

Councilwoman Campbell brought up the Noise Ordinance – what kind of noises need variances; shouldn't police respond for complaint instead of Building Inspector? Ordinance still needs to be worked on.

Supervisor Helsmoortel is checking in to the Guardian Dental Plan with better coverage and less expense.

Supervisor Helsmoortel and Councilman Leighton are applying to Greenway for grants to work on Esopus Creek sewer and water situation.

Kent Boyer is designing signs needed at Town Hall.
