Councilman Leighton – Praetorius and Conrad generated hydraulic analysis for Glasco Water District for August 2006, which was requested by the Planning Board. NYS DEC has conducted annual inspection and found no problems or violations. Wayne Debrosky is still working on the district maps.

Councilwoman Thornton – library budget passed and will maintain the current location. CAC meeting will be September 21st at 7:00 p.m., looking for volunteers, commitment of several hours per week regarding bio-diversity study. October 4th CAC will be at the preboard meeting with Catskill Center to discuss up-coming charette. CPC next meeting is September 28th at 7:00 p.m. Channel 23 committee has been working diligently and Scott Wickham from the school will be working with the committee videotaping. Historical Society is holding their chicken barbeque Mum Festival weekend.

Councilman Costello – just a reminder that Garlic Festival is this coming weekend. Glasco Mini Park has 70 ton concrete and steel being installed. Warehouse renovation going well, looking forward to moving offices in that space, staff did an excellent job.

Councilwoman Campbell – Economic Development will have Les Newman as a speaker on September 25th and on October 3rd is hosting sustainable Hudson Valley. The paper signs popping up around gas stations and businesses are not allowed according to Tom Story at NYS DOT.

Motion made by Councilwoman Campbell, seconded by Councilman Costello to adopt Local Law #1 of 2006 Providing for the Administration and Enforcement of the New York State Uniform Fire Prevention and Building Code, as read:

A LOCAL LAW PROVIDING FOR THE ADMINISTRATION AND ENFORCEMENT OF THE NEW YORK STATE UNIFORM FIRE PREVENTION AND BUILDING CODE

Local Law # 1 of 2006

Be it enacted by the Town Board of the Town of Saugerties, in the County of Ulster, New York as follows:

PURPOSE AND INTENT

This local law provides for the administration and enforcement of the New York State Uniform Fire Prevention and Building Code (the Uniform Code), the Property Maintenance Code (the Property Code), and the State Energy Conservation Construction Code (the Energy Code) in the Town of Saugerties. This local law is adopted pursuant to Section 10 of the Municipal Home Rule Law. Except as otherwise provided in the Uniform Code, other state law, or other section of this local law, all buildings, structures, and premises, regardless of use or occupancy, are subject to the provisions of this local law.

Vote: Adopted – 5 Yes

Motion made by Councilwoman Thornton, seconded by Councilman Leighton to appoint Terri Schmidt as secretary to the Historic Preservation Commission at a rate of \$10.00

per hour effective immediately, as per the recommendation of the Historic Preservation Commission members.

Discussion: Councilwoman Thornton commented that Kelli Rae Gilmore has gone back to school and we thank her for her service and wish her well.

Vote: Adopted - 5 Yes

Motion made by Councilwoman Campbell, seconded by Supervisor Helsmoortel to approve, to a permanent status, Henry Ziegler's, Code Enforcement Officer for the Town of Saugerties, existing stipend.

Vote: Adopted – 5 Yes

Motion made by Councilman Costello, seconded by Councilman Leighton to appoint Ann Westergard to the part-time call out list at a rate of \$9.00 per hour, as per the recommendation of the Parks & Buildings Superintendent, Greg Chorvas.

Vote: Adopted – 5 Yes

Motion made by Supervisor Helsmoortel, seconded by Councilman Costello to approve the up-dated 2006 Town of Saugerties Highway Department Equipment Inventory, as per the Highway Superintendent, Bernie Ellsworth.

Vote: Adopted - 5 Yes

Motion made by Councilwoman Campbell, seconded by Councilman Leighton to accept the proposal from Barton & Loguidice, P.C. in regard to Land Use/Environmental Analysis for the Town of Saugerties which deals with the Planned Development District, PDD (RB Zoning Area- Washington Avenue, Canoe Hill and Mike Krout Road.)

Discussion: Councilwoman Campbell stated that this deals with proposed RB district, which had some discrepancies and this firm will clarify areas.

Vote: Adopted – 5 Yes

Motion made by Supervisor Helsmoortel, seconded by Councilman Costello to enter into Executive Session for the medical, financial, credit or employment history of a particular person or corporation or matters leading to the appointment, employment, promotion, demotion, discipline, suspension, dismissal or removal of a particular person or corporation and in addition pending litigation.
