# **TOWN BOARD MEETING – SEPTEMBER 15, 2021**

The Town Board Meeting was held on Wednesday, September 15, 2021 at 7:00 p.m. at the Frank D. Greco Multi-Purpose Building located at the corner of Market and Robinson Streets in the Village of Saugerties. The meeting opened with the Pledge of Allegiance with the following members present:

### **PUBLIC COMMENT PERIOD:**

Ray Mayone, Jr. – spoke in favor of Diaz Ambulance on behalf of the fire departments as an association and a group. Fire departments are being burdened because the ambulance only has two crews. We need and support a third full time crew. Third out calls average 15 per month in Glasco District alone.

Sean Rafferty – some fire departments only have basic first aid trained volunteers; a few companies are fortunate enough to have EMT trained volunteers in their fire company.

Councilman Ivino – you do not get the quality care from other ambulance companies like Diaz; also, you would be taking away from other communities when their ambulance is called out to help in your district.

Kevin Drescher – was under the impression that there have been meetings with Diaz in the past; we all need the facts and can not put a price on a life. In 1978, served on the board to bring Diaz as a district and am again willing to help.

Brian Breithaupt – remember to use dollar and cents instead of percentage of increase per district on individual tax bills.

Councilwoman Thornton – there was a full house at the last presentation of Diaz, people don't realize and I think it opened a lot of eyes. Don't think there is a family in town that wouldn't support an increase.

### **BOARD COMMITTEE REPORTS:**

Councilwoman Nau – Arts Commission is interviewing for two positions on their board. Councilwoman Thornton – library budget has passed and events are coming up, October 6<sup>th</sup> is a Halloween Trivia night. Boys & Girls Club is up in full swing and volunteers are needed. CPC will meet September 23<sup>rd</sup> and a Workshop was held yesterday regarding zoning issues. Councilman Ivino – Water and Sewer has new auger system; Building Department is busier all the time. RYAN House will hold a ribbon cutting on September 25<sup>th</sup> at 11:30 a.m. Councilman Schoonmaker – in support of RYAN House and on September 18<sup>th</sup> the Animal Shelter is holding a fundraiser.

Motion made by Councilwoman Nau, seconded by Councilwoman Thornton to appoint Officer Amber Kolts to 90 day temp position, effective September 20, 2021 and at a salary of \$23.60 per hour pending Civil Service approval.

Motion made by Councilwoman Thornton, seconded by Supervisor Costello to appoint Officer Erik Lilland to 90 day temp position, effective September 20, 2021 and at a salary of \$23.60 per hour pending Civil Service approval.

Vote: Adopted – 5 Yes

Motion made by Supervisor Costello, seconded by Councilman Ivino to accept the resignation of William Carr from the Highway Department effective September 2, 2021.

Discussion: Supervisor Costello said he is grateful for his time and Councilman Ivino thanked him for his active duty service.

Motion made by Councilman Ivino, seconded by Councilwoman Thornton to accept the resignation/retirement of Dean Fabiano effective September 29, 2021.

Discussion: Supervisor Costello said that Dean has had 40+ years in the highway department, he will be missed.

Vote: Adopted – 5 Yes

Motion made by Councilman Schoonmaker, seconded by Supervisor Costello to move Ryan Herschel from temporary full time to permanent full time, to fill previously vacated position, with no increase in current rate of pay as per the recommendation of the Parks & Buildings Superintendent.

Vote: Adopted - 5 Yes

Motion made by Councilwoman Nau, seconded by Councilwoman Thornton to set a public hearing for October 6, 2021 at 6:30 p.m. regarding Property Maintenance.

Discussion: Supervisor Costello explained that revisions have been made and we are holding another public hearing.

Vote: Adopted – 5 Yes

Motion made by Councilwoman Thornton, seconded by Councilman Ivino to allow the Supervisor to certify an application to be submitted on behalf of the Town Justice Court to the Justice Court Assistance Program for grant funds for the 2021-2022 grant cycle for an amount up to \$30,000.00.

Vote: Adopted – 5 Yes

Motion made by Supervisor Costello, seconded by Councilman Schoonmaker to approve the Fiberlinc MOU to develop private and public partnerships regarding fiber in Saugerties pending town attorney approval.

Discussion: Supervisor Costello said that this would enhance broadband service.

Vote: Adopted – 5 Yes

Motion made by Councilman Ivino, seconded by Councilwoman Thornton to allow the town to be designated as lead agency on the Winston Farm zoning change request.

Discussion: Councilman Ivino said he hopes to see this project through, it is a win-win.

Vote: Adopted – 5 Yes

Motion made by Supervisor Costello, seconded by Councilman Ivino to adjourn Town Board Meeting at 8:18 p.m., carried.
