PUBLIC COMMENT PERIOD:

Patti Kelly – asked the Town Board to go back to a roll call vote so the public knows how the members vote; more accountable.

PRIVILEGE OF FLOOR:

Engineers Brinnier & Larios gave a power point presentation regarding storm damage from Hurricane Irene and Lee and FEMA work in the Town of Saugerties. Town funding or in-kind service will be 12.5% of the amount. Supervisor Myers said that we will need to take out a BAN and FEMA will reimburse the Town of Saugerties. Resident Beth Murphy asked if repairs from previous 15 roads be deducted from the money the town pays. Councilman Costello added that this does not represent the entire impact of the storm. Greg Chorvas has had damage reimbursed through insurance.

SUPERVISOR'S COMMENTS:

Thanked Doug Myer for starting work a month early to get a jump start on his position. Father Berean thanked the Town Board for being flexible in the board meeting time. Attended newly elected conference with NYS in Albany. New health insurance for employees will start February 1st, thank you to the employees for being flexible. On January 23rd Michael Hein is hosting an Esopus Creek forum, all interested are invited to attend. Would also like to thank the department heads at town hall for being available to meet.

out yet, so that is the reason for the extended deadline. As a committee, we also give out advisory opinions, which is a good thing.

Councilman Leighton – thanked Glen and Ethics Committee for doing a great job. Disclosure forms are read on a state level, through auditors. Read final report from Building Department 2011, which is on file. Thank you to Building Department for a great job.

Councilwoman Thornton – TV23 for the last 24 hours has blown out a fuse in the modulator, problem has been solved. Workshop will be held on February 4th to bring skill and talent to the community; 36 people are trained in technology. Saugerties transportation has a new taxi service 845-399-2490. Library on March 12th will host a "Ride the Bus" to promote that service. CAC meets on January 19, 2012 on Emerald Ash bore. CPC has no major changes from water review from County. Lifespring has winter special events.

Councilman Costello – thanks Ethics Committee also for their service. The Ice Rink had 2,847 public skaters during the holidays!

Councilman Bruno - thank Mike Marino from the Village Sewer Department assisting with the truck. Mike Mower has a truck but we are holding off for now.

MOTIONS & RESOLUTIONS:

Motion made by Councilman Costello, seconded by Councilman Leighton to approve rehiring Brian T. Ellsworth as a part time mechanic at a rate of \$15.00 per hour on an as needed basis, per the recommendation of the Highway Superintendent effective January 13, 2012.

Motion made by Councilman Costello, seconded by Councilman Bruno to approve the resolution, as on file, authorizing repairs to town roads, culverts and bridges.

Discussion: Supervisor Myers added that it was a great discussion from Brinnier & Larios. Vote: Adopted – 5 Yes

Motion made by Councilman Costello, seconded by Councilman Leighton to approve the revised and updated "Minimum Standard Requirements" for establishing new town roads per the recommendation of the Highway Superintendent.

Discussion: Supervisor Myers said that Doug Myer did a fantastic job re-writing and approved by Brinnier & Larios and the town attorney. Vote: Adopted – 5 Yes Motion made by Councilman Bruno, seconded by Councilman Leighton to accept the resignation of Miles Putnam from the Historic Preservation Commission effective immediately.

Discussion: Councilman Bruno thanked Miles for his service and he is leaving for personal reasons. Councilwoman Thornton added that he was known as the "map man" and special thanks for his hard work and talent. Vote: Adopted – 5 Yes

Motion made by Councilman Leighton, seconded by Councilman Bruno to approve the sale of one surplus snowplow for the sum of \$5,000.00 to the Town of Fallsburg per the recommendation of the Highway Superintendent. Vote: Adopted – 5 Yes

Motion made by Councilman Leighton, seconded by Councilwoman Thornton to allow Eileen Pistoia to carry over into 2012 10.25 hours of personal time and 17.75 hours of vacation time.

Discussion: Councilman Leighton said that the Court Clerks are overloaded and they do a great job. Vote: Adopted – 5 Yes

Motion made by Councilman Costello, seconded by Councilman Bruno to promote Michael Craft to the position of Sgt. with an annual stipend of \$3,500.00 effective July 26, 2011.

Discussion: Councilman Costello added that Sgt. Craft has held this position but it's just a matter of "housekeeping" to have this motion. Vote: Adopted – 5 Yes

Motion made by Councilman Costello, seconded by Councilman Bruno to appoint Ryan Hample as a permanent full time police officer at a rate of \$20.35 per hour, effective April 9, 2011.

Discussion: Councilman Costello added that he gives outstanding service and look forward to continued service. Vote: Adopted – 5 Yes

Motion made by Councilman Bruno, seconded by Councilman Costello to appoint Supervisor Kelly Myers as the delegate for the 2012 annual meeting of the Association of Towns of the State of New York. Vote: Adopted - 5 Yes

Discussion: Councilman Leighton clarified that the Ethics Committee elects their own chair.
