BOARD COMMITTEE REPORTS:

Councilman Leighton – Diaz Ambulance reported 162 calls in January 2009 with 100% compliance. Boys & Girls Club will hold their Spring Fling Auction on March 28th at 6:00 p.m. DEC sent a letter that Malden Wastewater Plant was in satisfactory condition.

Councilwoman Thornton – Reality Check spoke at the last board meeting and in April they will do a live show on TV23. Marjory Block filmed the Village Candidate Night last night, which will show shortly. Time Warner has \$2,000.00 scholarship available. Chief Barbaria attended the SAMA meeting to discuss traffic flow. CPC working on land use disturbance. Bio-diversity working on map for Hudsonia.

Councilman Costello – our police department has highest rate in county for arrests for DWI, compliments to the department. The Recreation Department is replacing the sign on Market Street to Cantine Field and looking into relocating police impound area. Recently, family had a structure fire and wanted to thank the fire department with utmost gratitude for their efforts. Library Board will be paying for renovations to the town hall warehouse for their use while construction is going on. There is a draft of the diagram for Bishops Gate Lighting District.

Councilwoman Campbell – thanked Patti Kelly and the Green Energy Task Force for holding forum. Results of the survey on Winston Farm had a 86% positive response. There were over 377 surveys returned. Dan Schuster met with GEIS and will have the first draft by the end of April. Building Department revenues are down; one building inspector has been laid off and Jeremy Kane will be decreasing his hours. The Greg & Bob Show will be live on Saturday.

Motion made by Councilman Costello, seconded by Councilman Leighton to approve the 2009 contract, as on file, for DWI Task Force Patrols in the Town of Saugerties between the Town of Saugerties Police Department and the County of Ulster.

Vote: Adopted – 5 Yes

Motion made by Councilman Leighton, seconded by Councilman Costello to approve an easement of LeRoy Holdings and others with the Town of Saugerties and Malden Water and Sewer District, as on file.

Vote: Adopted – 5 Yes

Motion made by Councilwoman Thornton, seconded by Councilman Costello to accept the resignation of Doug Engel on the Comprehensive Plan Committee effective March 4, 2009.

Vote: Adopted – 5 Yes

Motion made by Councilwoman Thornton, seconded by Councilwoman Campbell to authorize the Historic Preservation Commission to charge a fee for the Saugerties Stone House Tour on May 16, 2009 that will cover the expenses incurred by the commission.

Motion made by Supervisor Helsmoortel, seconded by Councilman Costello to allow Bernie Ellsworth, Highway Superintendent to forgo competitive bidding to replace a totally damaged highway vehicle due to an insurance covered fire per General Municipal Law, Article 5-A, Section 103 paragraph 4.
