Joe Roberti, Sr. – read in paper on naming of Town Hall after Greg Helsmoortel. There was a motion in 2001 to name the Town Hall after Col. Roger Donlon. Why wasn't there

any action taken on that motion in ten years. Feels the original resolution needs to be honored.

Motion made by Councilman Costello, seconded by Councilman Leighton to declare surplus and no longer of any use to the Town of Saugerties one (1) 1995 Ford, F350XL, One Ton Dump Truck, Vin#2FDKF38G8TCA56321, as per the recommendation of Parks & Buildings Superintendent.

Vote: Adopted – 5 Yes

Motion made by Councilman Costello, seconded by Councilman Bruno to authorize advertising for proposals for the sale of one (1) 1994 Ford, F350XL, One Ton Dump Truck Vin#1FDKF38GOREA18035 and one (1) 1995 Ford, F350XL, One Ton Dump Truck, Vin#2FDKF38G8TCA56321, as per the previous adopted motions and further, per the recommendation of the Parks & Buildings Superintendent.

Discussion: Councilman Costello added that both trucks have been in service a number of years.

Vote: Adopted – 5 Yes

Motion made by Councilman Costello, seconded by Councilman Leighton to approve the User and Facility Fee increases for private ice time, at the Kiwanis Ice Arena, for the upcoming 2012-13 ice season, as follows: Category A Use \$210.00/hour; Category B Use \$185.00/hour; Category C Use \$170.00/1.5 hours; Category D Use \$155.00/1.5 hours and Category E Use \$145.00/1.5 hours.

Vote: Adopted – 5 Yes

Motion made by Councilman Bruno, seconded by Councilman Costello to authorize the Highway Superintendent to dispose of one surplus 1974 OSH KOSH 4 wheel drive plow truck.

Discussion: Supervisor Myers said by getting rid of this vehicle, we will be able to recoup some money.

Vote: Adopted – 5 Yes

Motion made by Councilman Bruno, seconded by Councilman Leighton to contract with Susan Trnka to act as a back up as an Animal Control Officer for the town in emergency situations when our town ACO is not available at a cost of \$65.00 per call per Animal Shelter Manager.

Discussion: Councilman Leighton said Sue Trnka has done this for many years and she does a great job.

Vote: Adopted – 5 Yes

Motion made by Councilman Bruno, seconded by Councilman Costello to accept, with regret, the resignation of Carla Vollheim a part time animal shelter worker due to health reasons.

Vote: Adopted - 5 Yes

Motion made by Councilman Bruno, seconded by Councilman Costello to hire Taylor Dugan as a part time Animal Shelter Worker at a rate of \$10.00 per hour to be on an "as needed basis" hiring effective May 3, 2012, per the Animal Shelter Manager.

Vote: Adopted - 5 Yes

Motion made by Supervisor Myers, seconded by Councilwoman Thornton to approve the resolution, as on file, authorizing the Highway Superintendent to enter into temporary construction easements for road repair and replacement of the Kate Yaeger Road bridge under contract TSA-123: FEMA 4020.

Vote: Adopted - 5 Yes

Motion made by Councilwoman Thornton, seconded by Supervisor Myers to allow the  $5^{th}$  Annual Tour of the Catskills Cycling Race Stage 2 Road Race to take place on August 4, 2012 per the request of the event organizer/race promoter along the following roads in the Town of Saugerties – State Route 32, County Route 35, County Route 33 and Platte Clove Road and per the approval of the Highway Superintendent and the Chief of Police. Vote: Adopted – 5 Yes

Motion made by Councilman Leighton, seconded by Councilman Costello to appoint Howard Post, Planning Board Chair, to the Ulster County Planning Board as an alternate to represent the Town of Saugerties.

Discussion: Supervisor Myers said there was one vacancy to fill.

Vote: Adopted – 5 Yes

Motion made by Councilman Bruno, seconded by Councilwoman Thornton to allow the Sueprvisor to seek bids for waste disposal at the Transfer Station.

Discussion: Supervisor Myers added that the RRA Contract is up for renewal in October. Vote: Adopted – 5 Yes

Motion made by Supervisor Myers, seconded by Councilman Costello to recognize May 5, 2012 as the Saugerties Sports Hall of Fame Inductee Day to celebrate the accomplishments of Bill Eckoff, Shelly Pfiel, Dr. Sharon Misasi, D. Holley Carnright and Jay Harris.

Vote: Adopted – 5 Yes

Motion made by Councilman Leighton, seconded by Councilwoman Thornton to accept the resignation of Judge Wendy Ricks effective May 13, 2012.

Discussion: Councilman Leighton congratulated Wendy on her new position with Ulster County – she did a great job for the town.

Vote: Adopted – 5 Yes

Motion made by Supervisor Myers, seconded by Councilman Bruno to approve a donation of \$1,500.00 to the Sawyer Motors Car Show for 2012.

Discussion: Supervisor Myers said that proceeds will go to Make-a-Wish to benefit a young person in our town. Councilman Costello added that this is a wonderful event. Vote: Adopted – 5 Yes

Motion made by Supervisor Myers, seconded by Councilman Costello to approve hiring Gene Gruner, Real Estate Appraiser at a rate of \$6,750.00 to perform an appraisal that is needed to defend the town's position in the 2011 Article 7 tax certiorari against Winston Farms.

Discussion: Supervisor Myers doesn't like to spend this money but it must be done. Vote: Adopted – 5 Yes

Motion made by Supervisor Myers, seconded by Councilman Bruno to enter into Executive Session regarding matters leading to the appointment, employment, promotion, demotion, discipline, suspension, dismissal or removal of a particular person or corporation, at 9:15 p.m., carried.

Motion made by Supervisor Myers, seconded by Councilman Leighton to exit Executive Session and adjourn Town Board Meeting at 10:45 p.m., carried.
