PUBLIC COMMENT PERIOD:

Doug Pettit – thanked three Town Board members – Costello, Thornton and Bruno and Pete Lopez for attending the meeting at Glasco Fire Department regarding Dickenson's Keep. There was a referendum for the Library expansion for residents to make a decision but not on a project like this.

Brian Carmody – safety of streets – spoke two weeks ago and has more information for the board to read. Governor Cuomo has signed a safe streets law. This should have walk-ability and bike-ability.

Councilman Leighton – read Building Inspector monthly report.

Councilwoman Thornton – TV23 had problems and is now fixed. Town and Village Comprehensive committee met and is going over goals and plan that was written in 1999. CAC info workshop regarding easements. Lighthouse auction will be October 8th at the Kiersted House.

Councilman Bruno – last week Mark Resso met with company to replace water meters – no moving parts – trying to get a grant. All meters could be read in 2 to 3 hours instead of 4 days.

MOTIONS & RESOLUTIONS:

Motion made by Councilman Bruno, seconded by Councilwoman Thornton to authorize John J. Greco, Esq., as attorney for the Town of Saugerties, to settle the pending real property tax assessment review proceeding in the matter of Robert Imbierowic vs. Assessor Frank Orlando and the Board of Assessment Review of the Town and Village of Saugerties, pending in Ulster County Supreme Court, Index Number 10-3995, in accordance with the Stipulation of Settlement on file with the Assessor of the Town of Saugerties.

Vote: Adopted – 4 Yes (Councilman Costello absent)

Motion made by Supervisor Helsmoortel, seconded by Councilman Leighton to approve the Letter of Agreement, as on file, between the Ulster County Resource Recovery Agency and the Town of Saugerties regarding the offer from the Ulster County Resource Recovery Agency to defer payment of the costs incurred by the Town of Saugerties for the agency's hauling and disposal of debris caused by Tropical Storm Lee and Hurricane Irene.

Discussion: Supervisor Helsmoortel added that the Transfer Station took debris for two weeks from residents from the flood at no charge. Vote: Adopted – 4 Yes (Councilman Costello absent)

Motion made by Councilwoman Thornton, seconded by Councilman Leighton to approve the Resolution, as on file, regarding the Shared Services Agreement (also on file) with Ulster County concerning county roads within the Town of Saugerties. Vote: Adopted – 4 Yes (Councilman Costello absent)

Motion made by Councilman Leighton, seconded by Supervisor Helsmoortel to approve the Resolution, as on file, authorizing the Town Justices to apply for grant funds from the Justice Court Assistance Program with the Supervisor being authorized to certify such application.

Vote: Adopted – 4 Yes (Councilman Costello absent)

Motion made by Supervisor Helsmoortel, seconded by Councilman Leighton to approve the Resolution, as on file, declaring a public emergency for the Hemlock Lane repair project pursuant to General Municipal Law 103(4). Vote: Adopted – 4 Yes (Councilman Costello absent)

Motion made by Supervisor Helsmoortel, seconded by Councilman Leighton to adjourn Town Board Meeting, carried.

Councilman Bruno read a letter from Bernie Ellsworth thanking the Town of Saugerties Highway and Town Board for support during storms. Benson Steel has helped tremendously – thank you to all residents for support.
