Motion made by Councilman Costello, seconded by Councilman Schirmer to accept the resignation from Dylan Eusepi as a part time dispatcher, effective July 18, 2017. Vote: Adopted – 5 Yes

Motion made by Councilman Bruno, seconded by Councilman Schirmer to approve an overpayment of \$100.00 to Carole Cantius paid on receipt #B13073. Discussion: Councilman Bruno said this was through the Building Department. Vote: Adopted – 5 Yes

Motion made by Councilman Costello, seconded by Supervisor Helsmoortel to add to the Parks & Building part time call out list, Jeroy Gordon at a rate of \$10.50/hour, as per the recommendation of the Parks & Buildings Superintendent. Discussion: Councilman Costello said college help is going back and need more people. Vote: Adopted – 5 Yes Motion made by Councilman Costello, seconded by Councilwoman Thornton to name SAA Women's Field #8, in the Cantine Veterans Sports Complex, "Fritz Beckert Memorial Field", as per the recommendation of the Recreation Committee and the Parks & Buildings Superintendent.

Discussion: Councilman Costello said that Fritz spent a lot of time at the field volunteering. Vote: Adopted – 5 Yes

Motion made by Councilwoman Thornton, seconded by Councilman Costello to hire Jeannine Mayer as a part time clerk at \$14.00 per hour, on an as needed basis and effective August 18, 2017.

Discussion: Supervisor Helsmoortel added that Jeannine just retired from M&T Bank. Vote: Adopted – 5 Yes

Motion made by Councilman Costello, seconded by Supervisor Helsmoortel that the town board hereby approves a contract bid of \$7,498.44 by LilyPad EV of 9801 W. 100<sup>th</sup> Terrace, Overland Park, KS 66212 (quote #909) for a ChargePoint: CT4021-GW1 Dual Output Gateway Option USA, Bollard Unit – 208/240V @30A with Cord Management Electric Vehicle charging station, as per the Ulster County bid award, with Prepaid Commercial Cloud Plan, to be installed in-house under the terms of NYSDEC Contract No. DEC01-T00298GG-3350000, and to secure reimbursements for such station and installation through the DEC contract terms. At the end of the two year commitment with NYS, the Town of Saugerties will not be responsible for cost but will go to the users.
