TOWN BOARD MEETING – APRIL 2, 2025

PRIVILEGE OF FLOOR:

Peter Engelhart, HITS – gave an update and saying they are excited about 2025, purchased HITS from Tom Struzzi three years ago and will have 15 events this year. The shows run from mid-May through mid-October. They would like to increase spectators to the grounds to promote the equestrian events. HITS is in a relationship with United Way to help charities. Would like to ask the board to consider renaming a portion of Mike Kraut Road to Equestrian Way.

PUBLIC COMMENT PERIOD:

Marc Brodtkin – proposed development at Winston Farm would be devastating, we need to respect habitat; bird habitats are diminishing.

Janell O'Rourke – Hudson Valley remains one of the richest areas in NYS; this development would be catastrophic to eco-system and it should be preserved.

MOTIONS & RESOLUTIONS:

Motion made by Councilman Ivino, seconded by Councilwoman Thornton to accept the proposal from Choice Words for professional grant writing services, along with submission to New York State's Municipal Parks & Recreation Grant Program (MPR), in the amount of \$4,000.00, for the proposed Saugerties Splash Pad, as per the recommendation of the Parks & Buildings Superintendent.

Vote: Adopted – 5 Yes

Motion made by Councilman Horton, seconded by Councilwoman Thornton to authorize Choice Words to proceed with completion and submission of a grant to New York State's Municipal Parks & Recreation Grant Program (MPR) for the Saugerties Splash Pad, as per the recommendation of the Parks & Buildings Superintendent.

Vote: Adopted – 5 Yes

Motion made by Councilwoman Nau, seconded by Councilman Horton to award the sealed bid for the installation of Pickleball Courts lighting and related to Richers Electric in the amount of \$47,800.00 as per the recommendation of the Parks & Buildings Superintendent.

Vote: Adopted – 5 Yes

Motion made by Councilwoman Thornton, seconded by Supervisor Costello to move Officer Jackie Zhang from Provisional full time Officer back to a part time Officer, effective April 1, 2025, to be paid at the rate of \$30.00 per hour.

Vote: Adopted – 5 Yes

Motion made by Supervisor Costello, seconded by Councilman Horton to appoint Officer Bryan Nunez as a permanent full time Police Officer, off the Civil Service Certification of Eligibles, effective Monday, April 7, 2025, to be paid at the rate of \$26.64 per hour.

Discussion: Supervisor Costello added that Bryan has been with us a little over a year, it's good to have him.

Vote: Adopted – 5 Yes

Motion made by Councilman Ivino, seconded by Councilman Horton to appoint Officer Ryan Cioni as a permanent full time Police Officer, off the Civil Service Certification of Eligibles, effective Monday, April 7, 2025, to be paid at the rate of \$26.64 per hour.

Vote: Adopted – 5 Yes

Motion made by Councilman Horton, seconded by Councilman Ivino to approve the two (2) independent accountant's reports on applying agreed-upon procedures, as on file, in regards to the Justice Court.

Discussion: Supervisor Costello added that there are unique circumstances with Justice Court and would like to apply recommended applications.

Vote: Adopted – 5 Yes

Motion made by Supervisor Costello, seconded by Councilman Horton to adjourn Town Board Meeting at 8:18 p.m., carried.
