- Patrick Walden and Laura Kopczak from Arm of the Sea gave a presentation that included a slide presentation
  - Arm of the Sea
  - History and future plans for Tidewater Center
    - Outdoor venue planned to open next summer (Covid safe)
    - Process of cleaning up a contaminated site and turning it into a community access area
    - \$100K is needed for phase one. \$40K has been received from a grant. Looks like \$1Million for entire completed project
    - Local funders: Bob Siracusano (Sawyer Motors), Tom Struzzieri (meetings secured), Jimmy Fallon and letters of inquiry sent out to others as well. They are looking for individuals that can support the project.
    - Set up an Indi-go-go campaign with matching funds will get the whole community involved. Isabel has
      experience with this and could discuss further.
    - Have mostly been in communication with the Village of Saugerties
    - Kiwanis Club has made a \$12,000 donation in the early stages of development; presented to Chamber of Commerce, Esopus Creek Conservancy; soliciting in kind services from Saugerties businesses to get them involved (i.e.: John Mullen); Barbara will make arrangements for Patrick to meet with Chamber (they haven't seen the plans)
    - Patrick will make documents available to board members
- Future speakers: Jennifer Russell (Saugerties Public Library Director) / Addie Farr (Director Kingston Dept. of Art and Cultural Affairs)
- It wasn't on the agenda, but how would we move forward now that Barbara is leaving and Katie's responsibilities would be limited
  - Barbara suggests we have a meeting before January 2021
  - Need to send out calls for new board members (needs to be public). Robert can pull text from last call.
  - Isabel suggests that we change meetings to twice a month for the meantime. We will need to meet the first couple of weeks in January
  - Barbara sent out a zip file that included the agendas of 2020, public art policy, proposed articles on artists, and whatever else has been in progress; a file of admin work that needs to be done monthly, budgets, and other materials that we'll need to carry on. Files are in drop box

## **FINANCES**

- Have we received funding for 2021? Did not confirm with Leanne but budget has been approved.
- SEO Web mechanics has been paid in full
- Payment for I Can Do That has been processed and should go through easily
- Website service has been paid by Isabel
- We can do early renewal now on domain names. Isabel will process early renewal.
- There will be a balance left over of \$1200+. Not sure of it includes the \$500 retainer and vouchers being submitted. Balance cannot be carried over to next year.
- Barbara reached out to Kathleen Grey to see if she could look out for grants, but it turned out to be a dead end at this time.
   Most funding is for non-profit orgs and not municipalities
- If we want to use the remainder for social media we would need to speak with Leanne before the end of the year. In 2021 budget there is \$1000 held aside for social media.
- There may be some funds allocated for next year that we may not use for their original intent
- We can get small payments reimbursed.
- For larger expenditures work with Leanne and check with board members before proceeding.
- Zip folders contains a Year End Report of what SAC did (and could not do because of COVID) for the year and was presented to the town through Leanne. This is an annual requirement.
