The Town Board Meeting was held at the Frank D. Greco Multi-Purpose Building located on the corner of Market & Robinson Streets in the Village of Saugerties on December 15, 2004. The meeting was called to order at 6:00 pm with the Pledge of Allegiance with the following members present:

Motion made by Supervisor Helsmoortel, seconded by Councilman Macarille to enter into Executive Session for the purposes of discussions and matters relating to collective bargaining negotiations under the Taylor Law.

Greg Chorvas approached the board to recommend fee increases on facility use for the year 2005.

PRIVILEGE OF FLOOR:

Barbara Budik, *Chairwoman of Ecomonic Development Committee*: spoke on *Swamp Thing*, artificial wetlands. Would like board to consider this for Kings Highway infrastructure, not only to promote new business but keep the businesses that are already there.

PUBLIC COMMENT PERIOD:

Steve Hahn – resides at 216 Churchland Road and reiterated topic of assessment being equal for all residents.

SUPERVISOR'S COMMENTS:

A reminder that town hall will be closed on Friday, December 24 for Christmas and also Friday, December 31 for New Year's – the transfer station will be open both of these days but will be closed on Christmas Day and New Year's Day.

I would like to congratulate Animal Shelter Manager Marie Post on receiving 1250 pounds of Purina Cat Food for our shelter. Someone who adopted a cat from our shelter turned in a comment card from the Homeless Home adoption kits that are handed out when a cat is adopted from our shelter. The card was randomly chosen which awarded our shelter the cat food. Marie said the shipment arrived yesterday.

In the past week the Town has received its second state aid mortgage tax check which brings the total amount received at over \$668,000 – almost \$300,000 more than was budgeted – In addition, the town received another Ulster County Sales tax check of over \$78,000 which also is about \$27,000 more than we had budgeted for this year.
